The district sought input in a variety of ways to identify needs for students academic recovery. This included but is not limited to meeting with Site councils (parent groups) at all school sites, staff meetings at the school sites, and discussions with certificated and classified groups. Additionally suggestions were solicited using parent square.

The District has utilized a multi-tiered system of assessment including classroom progress reports, IReady assessments (each trimester), fluency, and ELPAC data. Additionally CAASPP results will also be utilized.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

Parents and guardians will be informed of the opportunities for supplemental instruction and support through communications from the teacher, school site and district using Parent Square and other communication modalities.

A description of the LEA’s plan to provide supplemental instruction and support.

The district will provide supplemental instruction and support through extending learning time with tutoring, summer school, summer camps, enrichment programs, expanded after school transportation, and expanded club opportunities. Additional paraprofessional support, ELD coordinator, newcomer groups for EL's will also be provided. Internet access is also being extended throughout the community at no cost to

address the digital divide. Additional professional development will also occur to increase academic recovery and to continue the focus on SEL.
