Affidavit for Parent and Child Sharing a Residence with Another Adult

TO PARENT/GUARDIAN: This affidavit is required when you reside in a place in which your name does not appear on the deed, lease or rental agreement, or other official documentation. 3. This affidavit will expire at the end of the current school year.
